6. That the College shall send to the University, the progress reports of the compliance of the above conditions from time to time.
7. The conditions of First Time Affiliation and the observations stipulated by the Local Inquiry Committee shall also be complied with by the Trust/Sanstha/Mandal/Society within the given time limit.
